On motion by Ms. Micki Callahan, seconded and carried, the WISF Board approved the meeting minutes of the February 24, 2010 WISF Meeting.

## **Director's Report**

*(Discussion Item)*

Ms. Rhonda Simmons gave an update on the status of the Workforce Development system. Ms. Simmons reflected on the progress made by the Workforce Development Division in the past four years.

## **Economic Update**

*(Discussion Item)*

Mr. Ted Egan presented on Economic indicators for the City of San Francisco. Evidence suggests that San Francisco has hit bottom and is beginning to show signs of recovery in job growth and the real estate market. However, Mr. Egan did caution that the City is not out of the recession yet and that there are several global and local issues which may stunt economic growth.

Mr. Trent Rhorer presented on the status of the Jobs NOW program, with 1300 San Francisco residents being placed in private, non-profit and public sector jobs.

## **Election of the Chair**

*(Action Item)*

Mr. Dexter Ligot-Gordon presented on the process and requirements for Election of the Chair as described in the WISF bylaws. Mr. Rob Black was nominated at the February 24, 2010 meeting of the WISF. Nominations were opened and no further nominations made.

Nominations were then closed with Mr. Rob Black as the only nominee.

*On motion by Ms. Micki Callahan, seconded and carried, Mr. Rob Black was unanimously Elected Chair of the WISF.*

## **Action to Approve Local Plan Modification PY 09-10**

*(Action Item)*

Mr. Marc Majors presented on the Local Plan Modification for PY09-10, a technical document required to update the Employment Development Division (EDD) on Workforce Investment Act (WIA) program activities in the City and County of San Francisco. The most significant changes were in the increase in Dislocated Worker funds and American Reinvestment and Recovery Act (ARRA) dollars; the addition of Summer Youth Employment; implementing three Sector Academies: CityBuild, Health Care and TrainGreenSF; the expansion of the One Stop system to include a Neighborhood Workforce Center in Visitation Valley and a Re-Entry Navigator; and the California New Start Program to integrate recently paroled men and women into the San Francisco Workforce system.

Discussion followed.

*On motion by Ms. Barbara Garcia, seconded and carried, the Local Plan Modification PY 09-10 was passed unanimously.*

**Committee Reports**  
*(Discussion Item)*

Mr. Glenn Eagleson reported on the work of the Youth Council. Mr. Eagleson gave an update on the DCYF Raising San Franciscans Together Request for Proposal that was recently released with education attainment as the priority for young people 13-24 years old.

Discussion followed.

Ms. Cameron McHenry presented on the work of the Workforce Investment Community Advisory Committee (WiCAC). Ms. McHenry discussed the challenges of the WiCAC in nominating a Chair and requested that there be a standing agenda item for a WiCAC presentation at all future WISF meetings and public comment taken until such time that they could get representation on the WiCAC Board.

Discussion followed.

Mr. Rob Black commented that further conversation would be had in order to determine how best to have the WiCAC liaise with the WISF.

**Public Comment**

Mr. Rob Black's call for public comment yielded the following response:

Mr. David Bach, LGBT Community Center, commented in favor of having the voice of the WiCAC at the WISF table.

Mr. Joe Ramirez-Forcier, Positive Resource Center, commented in favor of giving the WiCAC, even in a non-voting role with a seat at the WISF table.

Ms. Jeaneane Young, Public Defenders Office, commented on outreach for the U.S. Census.

*Ms. Rhonda Simmons proposed that in the interest of time Agenda Items #7 and #8 be carried over to the next WISF meeting on August 25, 2010.*
