Roll Call

Michael Wald, Chair, called the meeting to order at 4:10pm.

Agenda

(Action Item)

On motion by Michael Wald, seconded by Rachel Antrobus, the Youth Council adopted the agenda.

Minutes

(Action Item)

On motion by Michael Wald, seconded by Lorne Needle, the Youth Council approved the meeting minutes of the October 14, 2009.

Chair's Report

(Discussion Item)

Michael Wald, Chair, stated that the Youth Council and committees have been doing a lot of work towards bringing youth workforce training where it should be in the City. The Youth Council Board will be voting on two action items. Action item #1 is regarding the approval of recommended directions from the Education Working Group. Action item #2 is regarding approval of the general structure of OEWD youth workforce proposal, in addition the Youth Council will vote on the funding frameworks of the RFP. The RFP is a joint effort between OEWD and DCYF for 10 to 15 million dollars of workforce money.

Working Group Updates

(Action Item)

Ciara Wade presented on the Quality Standards Working Group update. The Youth Employment Coalition will be hosting a meeting on December 3, 2009 at JVS to discuss how quality standards will be applied and how the standards will impact organizations applying for funding.

Michael Wald added that the Quality Standards that have been adopted by the Youth Council have been adopted in the RFP.

Discussion followed.

Lorne Needle presented on the Education Working Group's recommended goals, priorities, and structure of youth workforce programs.

Brian Cheu inquired about the disconnected youth between ages 18-24 and the expectation to get that particular group back into the workforce system.

Pete Gerhartz responded by stating that Larkin Street has a program called HireUp to help youth between the ages of 18-24 reconnect. The recommendations from the Education Working Group provide a framework as part of entry to get youth between the ages of 18-24 to get back into the workforce.

Discussion followed.

Carla Javits inquired about the role of the workforce system pertaining to education and if the workforce system is to act as a support system to the education system.

Rhonda Simmons responded that the workforce system is a mixture of both workforce and education. The issue depends on the economic context and the reality of today's economy is that there are not many jobs for people who are not highly educated, let alone people who have no skills. Because there are not a lot of jobs, more investment is put into getting people skilled up. DOL funds cannot be a safety net for education, there has to be some flexibility, but the end goal is getting people jobs.

Discussion followed.

On motion by Lorne Needle and seconded by Damon Lew the Youth Council approved the recommendations from the Education Working Group.

Staff Report

(Discussion Item)

Glenn Eagleson presented on DCYF/OEWD Youth Workforce Development Funding Strategies. The minimum quality standards adopted by the Youth Council will be clearly embedded and

reflected in the RFP. The RFP will be released tentatively in mid January. The bidders conference will be held in February and proposals will be due in March.

Conflict of Interest Policy
(Discussion Item)

Michael Wald informed members of the Youth Council of the Conflict of Interest Policy. Any member of the Youth Council who may have a conflict of interest due to their relationship to a potential applicant organization or through a family member, may not vote on or participate in discussions of the RFP framework.

Adoption of Funding Framework
(Action Item)

Kimberly Wicoff recommended that the goals and priorities of the Education Working Group recommendations be clear in the RFP.

Discussion followed.

Michael Wald added that the Youth Council Board does not have a formal role in the RFP. Much of the language in the RFP had been approved by the Citizen Advisory Committee.

On motion by Kimberly Wicoff and seconded by Carla Javits the Adoption of the WIA strategies of the Funding Framework was approved by the Youth Council with the recommendation with clarification on the language of the RFP to reflect the Education Working Group recommendations.
